C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Molly Branch. The tributary begins just outside of the project review area on S. Live Oak Drive and crosses under the S. Live Oak Drive and continues until it becomes tidal and flows into the West Branch of the Cooper River. The tributary is visible from aerial and ground photographs where a defined bed and bank, an OHW mark, and water in the channel were observed. The channel is also visible on LIDAR. The approximate drainage area of the subject reach of Molly Branch is approximately 780 acres, which appears to include uplands and wetlands. Based on this information, the offsite tributary was determined to have perennial flow.

The offsite tributary (Molly Branch) appears to begin in the wetland on the adjacent parcel and flows under the road through the wetland across of the road. Because the tributary flows through the larger wetland, the tributary and wetland share a boundary and the wetland has a direct hydrologic connection with the tributary. Therefore, the larger wetland, which include the onsite portion of the larger wetland, directly abuts the tributary.**
