C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses 1.33 acres , of which 0.15 acres are consider wetlands, located in Poplar, SC. The wetland addressed in this form continues offsite to the west until it intersects with Mill Swamp. Mill Swamp is an off-site tributary determined to be an RPW with perennial flow by review of aerial photographs, Horry County LiDAR, soil survey information and USGS topographic maps. USGS topographic survey information depicts a mostly cleared area with wetland symbols present in the western portion of the project area. This area was delineated was wetlands by the agent. The project area is comprised of the hydric soil Pocomoke and the partially hydric soil Eulonia. NWI maps map the project area as mostly uplands (U11) and forested wetlands in the area delineated at wetlands.
