B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Richland County LiDAR data showed a few geomorphic drainage features that were observed to be nothing more than ephemeral washes during the Corps' site visit on 3/20/2019. No other mapping or data depicts the presence of any jurisdictional features. This office agrees with the conclusions of the submitted information documented on this form. The project area consists entirely of dry lands.
