- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Located onsite are three upland excavated non-jurisdictional ditches that do not meet the criteria of a tributary, a single upland excavated non-jurisdictional pond, and 15 separate isolated wetlands totaling 13.32 acres (wetlands 1-12 & 14-16). The isolated wetlands were assessed per a previous JD (SAC-2007-01053, dated May 30, 2008), current aerial imagery, and current LiDAR data. The isolated wetlands were coordinated with USACE Isolated Waters and the EPA, coordination concluded on July 30, 2019, with no comments provided. All water contained within the wetland is retained within the wetland boundary and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other waters of the U.S. The onsite isolated wetlands were also determined to have NO substantial nexus to interstate (or foreign) commerce.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Located on-site are three upland excavated non-jurisdictional ditches that do not meet the criteria of a tributary, a single upland excavated non-jurisdictional pond, and 15 separate isolated wetlands totaling 13.32 acres (wetlands 1-12 & 14-16). The isolated wetlands were assessed per a previous JD (SAC-2007-01053, dated May 30, 2008), current aerial imagery, and current LiDAR data. The isolated wetlands were coordinated with USACE Isolated Waters and the EPA, coordination concluded on July 30, 2019, with no comments provided. Previous determination SAC-2007-01053 dated May 30, 2008. Horry County LiDAR aerial imagery depicts a generally flat site adjacent to the Kingston Lake floodplain. The site itself contains isolated depressions throughout with significant anthropogenic modifications in the southern portion of the site including excavated ditches and a pond.

This site was previously assessed May 30, 2008 under SAC-2007-01053. Only slight changes to the review area and jurisdictional resources have been on this assessment.

Data source information: HUC: 0304020608 (Kingston Lake). USGS Topographic Maps: Conway Quad, depicts a forested tract with one dashed blue line feature in the general area of a non-jurisdictional pond and non-jurisdictional pond in the southwestern portion of the site. Horry County NWI depicts the following symbology: U42P (uplands) & PFO4/1B (palustrine wetlands). Wetlands are depicted throughout the site. 2006 SCDNR infrared imagery; 2018 Google Earth Imagery. Photos from the site visit included with the submittal.

Assessed on this form was one 0.07 acre wetland that is a portion of a larger contiguous wetland system that directly intersects the MHW of Kingston Lake. This wetland was assessed and deemed jurisdictional in a previous JD, under SAC # 2007-01053, and dated May 30, 2008.

This site was assessed on two basis forms, non-jurisdictional resources are discussed on form 1 of 2 and jurisdictional resources are discussed on form 2 of 2.
