- ☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Potentially jurisdictional wetlands located within the project area were determined to be non-jurisdictional due to the lack of discernable or traceable outfall connections to other Waters of the US. Although in itself the wetlands meets the criteria set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement, soil survey information revealed that the wetland onsite is completely encompassed by soils that do not meet the hydrology criteria, and therefore disrupt any possible hydrologic connection to other wetlands or Waters of the US. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. Wetlands are depicted west of and adjacent to the property. However, there is a clear upland barrier between the onsite and offsite wetland depicted in Horry County LiDAR. Because of slight topographic elevation differences in the surrounding uplands any surface of subsurface hydrologic connection is inhibited. Wetlands to the north and east of the project boundary were also called isolated under SAC-2015-01364 and SAC-2008-01250 .**

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses 2 isolated non-jurisdictional wetlands in Murrells Inlet, SC. Although in itself the wetlands meets the criteria set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement, soil survey information revealed that the wetland onsite is completely encompassed by soils that do not meet the hydrology criteria, and therefore disrupt any possible hydrologic connection to other wetlands or Waters of the US. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. Wetlands are depicted west of and adjacent to the property. However, there is a clear upland barrier between the onsite and offsite wetland depicted in Horry County LiDAR. Because of slight topographic elevation differences in the surrounding uplands any surface or subsurface hydrologic connection is inhibited. Wetlands to the north and east of the project boundary were also called isolated under SAC-2015-01364 and SAC-2008-01250 .

Wetlands were coordinated with EPA and HQ on October 4, 2019 .
