site and adjacent parcel. This ditch is a manmade feature for the movement of storm-water and lacks the features of a tributary. This feature was assessed per remote data and found to be lacking any discernable surface water on a May 2019 Google Earth Street-View image and Google Earth imagery from 2011-2019. There are no aquatic features shown in the area of this ditch feature on USGS Topographic maps. Additionally, this feature is readily identifiable on LiDAR as a man-made linear ditch providing drainage from the roadside ditch (off-site) abutting highway 905 through the project site and terminating at the roadside ditch (off-site) St. Johns Circle. Due to a lack of hydrologic flow, a lack of a connection to any jurisdictional features, and the anthropogenic origins of this feature this feature is deemed non-jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other information (please specify): LiDAR depicts a generally flat site lacking any significant elevation feature changes. A drainage ditch is readily identifiable on LiDAR as a man-made linear feature on the eastern portion of the site providing drainage from the roadside ditch (off-site) abutting highway 905 through the project site and terminating at the roadside ditch (off-site) St. Johns Circle.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

This 6.90 acre project site is described as pine and deciduous hardwood silviculture plot last harvested in 2007 (per aerial imagery). The site was assessed in June of 2019 by the applicant’s consultant and was found to contain only uplands with no potential waters. Based on a remote verification using all available tools the Corps concurs with the consultant’s findings.

Non-jurisdictional features: Along the eastern project boundary is a ~920 linear foot excavated drainage ditch on the edge of the project site and adjacent parcel. This ditch is a manmade feature for the movement of storm-water and lacks the features of a tributary. This feature was assessed per remote data and found to be lacking any discernable surface water on a May 2019 Google Earth Street-View image and Google Earth imagery from 2011-2019. There are no aquatic features shown in the area of this ditch feature on USGS Topographic maps. Additionally, this feature is readily identifiable on LiDAR as a man-made linear ditch providing drainage from the roadside ditch (off-site) abutting highway 905 through the project site and terminating at the roadside ditch (off-site) St. Johns Circle. Due to a lack of hydrologic flow, a lack of a connection to any jurisdictional features, and the anthropogenic origins of this feature this feature is deemed non-jurisdictional.

USDA NRCS Soil Survey for Horry County depict one soil type within the project map, including: Yauannah fine sandy loam, which is listed as hydric for Horry County on the 2017 NRCS South Carolina Hydric Soils List. National wetland inventory maps depict approximately ¾ of the site as palustrine forested and scrub shrub wetlands (PFO4B / PSS1/4B). SC DNR 2006 Aerials; Google Earth 2011-2019. Site pictures provided by consultant; Google Street-View 2019. LiDAR depicts a generally flat site lacking any significant elevation feature changes. A drainage ditch is readily identifiable on LiDAR as a man-made linear feature on the eastern portion of the site providing drainage from the roadside ditch (off-site) abutting highway 905 through the project site and terminating at the roadside ditch (off-site) St. Johns Circle.

This site was assessed on a single-basis form, per the provided site maps and via remote resources.
