Summarize rationale supporting determination: **The Waccamaw River is subject to the ebb and flow of tides up to river mile 60; this project is adjacent to river mile 40, well-within the tidally influenced zone. Additionally, Report No. 7 of the U.S. Army Corps of Engineers 1977 Navigability Study: The Corps presently classifies the Waccamaw River as a "Navigable water of the U.S." between its mouth at Winyah Bay near Georgetown South Carolina to Lake Waccamaw (R.M. 140).**

Summarize rationale supporting conclusion that wetland is "adjacent": **On-site wetlands (Wetlands #s 2 and 3) are a part of a larger contiguous wetland ecosystem that intersects the OHWM of the Waccamaw River. The adjacency to the large tract of off-site wetlands to both on-site wetlands is only broken by a roadway (Highway 544), which is culverted to allow surface conductance from the on-site wetlands to wetlands off-site on the western side of Hwy 544, towards the Waccamaw drainage basin. Additionally, on-site Wetland #3 directly intersects the OHWM of an off-site unnamed perennial relatively permanent water (pRPW) (deemed jurisdictional on AJD # SAC-2017-01215, dated October 16, 2017), this pRPW provides surface water recharge wetlands that directly intersect the OHWM of the Waccamaw River.**

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This 13.65 acre project area is described as a forested tract bounded by Highway 544 to the west, Highway 31 to the south, a residential development to the east, and an unnamed tributary of the Waccamaw River to the north. Within the project site are two distinct wetland areas (1.52 + 0.45 = 1.97 acres total).

TNW adjacency: The Waccamaw River is subject to the ebb and flow of tides up to river mile 60; this project is adjacent to river mile 40, well-within the tidally influenced zone. Additionally, Report No. 7 of the U.S. Army Corps of Engineers 1977 Navigability Study: The Corps presently classifies the Waccamaw River as a "Navigable water of the U.S." between its mouth at Winyah Bay near Georgetown South Carolina to Lake Waccamaw (R.M. 140).

Wetland adjacency to TNW: On-site wetlands (Wetlands #s 2 and 3) are a part of a larger contiguous wetland ecosystem that intersects the OHWM of the Waccamaw River. The adjacency to the large tract of off-site wetlands to both on-site wetlands is only broken by a roadway (Highway 544), which is culverted to allow surface conductance from the on-site wetlands to wetlands off-site on the western side of Hwy 544, towards the Waccamaw drainage basin. Additionally, on-site Wetland #3 directly intersects the OHWM of an off-site unnamed perennial relatively permanent water (pRPW) (deemed jurisdictional on AJD # SAC-2017-01215, dated October 16, 2017), this pRPW provides surface water recharge wetlands that directly intersect the OHMW of the Waccamaw River.

Bucksville Quadrangle USGS topographic map depicts the forested project area as being bound to the west by Highway 544. An unnamed blue line (aquatic) feature crosses across the northern portion of the project site, this feature correlates to the approximate position and reach of off-site perennial RPW (deemed jurisdictional under AJD # SAC-2019-01215, dated October 16, 2017). No other features of note are shown within the project site. USDA / NRCS soil survey for Horry County, sheet 77, depicts three soils within the project site: Yauhannah fine sandy loam (0-2% slopes), Pokomoke fine sandy loam, and Lakeland sand (0-6% slopes). Yauhannah fine sandy loam and Pokomoke fine sandy loam are listed as hydric for Horry County on the NRCS 2017 Hydric Soils list for South Carolina. National Wetland Inventory (NWI) maps depict two areas of palustrine forested wetlands (PFO1/4C) within the project site; the two areas of NWI mapped wetlands approximately match up with the location and extent of on-site delineated resources. SC DNR 2006 Aerials; Google Earth 2005-2019. Site photos provided by The Brigman Company. LiDAR digital elevation model data depicts two depressional areas in the same location/extent of the on-site delineated resources. An off-site AJD was used when analyzing adjacency of on-site resources, AJD # SAC-2017-01215, dated October 16, 2017.

This site contains 1.97 acres of jurisdictional wetlands and 11.68 acres of non-jurisdictional uplands. This site was assessed per the provided site information and maps, on a single-basis form.
