**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Ogeechee loamy fine sand is listed as hydric for Horry County on the 2017 South Carolina Hydric Soils list. The data point obtained by the consultant consisted of a non-hydric soil lacking hydrological indicators. National wetland inventory maps depict the site as approximately one-half upland and one-half as persistently-vegetated seasonally-saturated palustrine emergent wetlands. Horry 1999 Aerial Index 11226:81; Google Earth 2005-2019; Site pictures submitted by The Brigman Company. LiDAR digital elevation model depicts an upland site with the remnants of human modified sand dunes and/or dredge/fill material piles.

This site was assessed on a single-basis form per the provided maps and site information.
