These features have been previously reviewed and documented under SAC 2007-899-2JX, Issued September 11, 2007; SAC 2007-00899-2JY, March 18, 2014, and most recently AJD SAC-2007-00899; Issued May 1, 2015. and Hillshade data, as well as historic aerial photographs indicates that there have been no significant changes to the landscape either within the project boundaries or in the surrounding area that would potentially alter the conditions onsite. Previous documentation indicates that Wetland B is 0.61 acres in size and is approximately 600 feet from the nearest jurisdictional wetland. Wetland B is approximately 2 feet below the elevation of the surrounding uplands which are mapped as Craven soil by NRCS and called uplands by the NWI (U42P). Wetland C is 0.21 acres in size and is approximately 400 feet from the nearest jurisdictional wetland. Wetland C is also approximately 2 feet below the elevation of the surrounding uplands which are mapped by the NWI as U42P and by the NRCS as Wahee soils. Both Wahee and Craven soils are generally found to be upland soil types in Berkeley County. The conclusion regarding no outfall to other waters is based not only on elevation differences as described above, but also on the minimal drainage area size associated with this wetland. The drainage area is not extensive enough to allow a sufficient volume of runoff to the isolated wetland so that any outfall of water could occur. Since no connection was found to other waters of the U.S., this depressional feature was determined to be isolated and therefore non-jurisdictional. There is no surface or apparent subsurface hydrologic connection to the jurisdictional wetlands, no apparent chemical connection, or any apparent biological connection, including any evident ecological interconnectivity. In addition, there is no apparent connection to interstate or foreign commerce, therefore, Wetland B and C were determined to be isolated and not regulated by Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Two small depressional features are located in the center portion of the subject property. These features have been previously reviewed and documented under SAC 2007-899-2JX, Issued September 11, 2007; SAC 2007-00899-2JY, March 18, 2014 and most recently AJD SAC-2007-00899; Issued May 1, 2015. A review of Berkeley County DEM and Hillshade data, as well as historic aerial photographs indicates that there have been no significant changes to the landscape either within the project boundaries or in the surrounding area that would potentially alter the conditions onsite. Previous documentation indicates that Wetland B is 0.61 acres in size and is approximately 600 feet from the nearest jurisdictional wetland. Wetland B is approximately 2 feet below the elevation of the surrounding uplands which are mapped as Craven soil by NRCS and called uplands by the NWI (U42P). Wetland C is 0.21 acres in size and is approximately 400 feet from the nearest jurisdictional wetland. Wetland C is also approximately 2 feet below the elevation of the surrounding uplands which are mapped by the NWI as U42P and by the NRCS as Wahee soils. Both Wahee and Craven soils are generally found to be upland soil types in Berkeley County. The conclusion regarding no outfall to other waters is based not only on elevation differences as described above, but also on the minimal drainage area size associated with this wetland. The drainage area is not extensive enough to allow a sufficient volume of runoff to the isolated wetland so that any outfall of water could occur. Since no connection was found to other waters of the U.S., this depressional feature was determined to be isolated and therefore non-jurisdictional. There is no surface or apparent subsurface hydrologic connection to the jurisdictional wetlands, no apparent chemical connection, or any apparent biological connection, including any evident ecological interconnectivity. In addition, there is no apparent connection to interstate or foreign commerce, therefore, Wetland B and C were determined to be isolated and not regulated by Section 404 of the Clean Water Act.

There is no known information to show that any of the aquatic resources documented on this form support a link to interstate or foreign commerce. There is no known information to suggest that these features are or may be used by interstate or foreign travelers for recreation or other purposes; produces fish or shellfish that could be taken and sold in interstate or foreign commerce or used for industrial purposes by industries in interstate or foreign commerce. The wetlands were determined to not be a WOTUS and not to be jurisdictional under the CWA.

The longest along the northwest property boundary is approximately 4,895 feet long, 4 feet wide and 3 feet deep. Approximately 550 feet of this conveyance is included in Wetland A, 730 feet in Wetland D and 187 feet in Wetland F. The second man-made conveyance is just south of the intersection of British Drive and Windsor Drive and is approximately 790 feet long, 3 feet wide and 2 feet deep. The third man-made conveyance is just southwest of the intersection of British Drive and Buckingham Drive and is approximately 307 feet long, 3 feet wide and 2 feet deep. The fourth man-made conveyance is just southwest of the intersection of British Drive and Dover Drive and is approximately 249 feet long, 3 feet wide and 2 feet deep. With the exception of the northwest boundary man-made conveyance portions that are included in wetlands A, D, and F, the balance of these man-made conveyances appear to have been excavated from uplands and do not exhibit signs of relatively permanent flow. None of these man-made conveyances have been maintained, and only the large conveyance along the northwest boundary was found to regularly contain water and aquatic vegetation. The lesser conveyances are shallow and contain only spotty aquatic vegetation. B. ADDITIONAL COMMENTS TO SUPPORT JD: A total of 200.44 acres out of 374.70 total project acres were determined to be jurisdictional and regulated by Section 404 of the Clean Water Act as they are adjacent to the Cooper River (TNW). Additionally, four man-made conveyances were found on the subject property. The longest along the northwest property boundary is approximately 4,895 feet long, 4 feet wide and 3 feet deep. Approximately 550 feet of this conveyance is included in Wetland 4 730 feet in Wetland D and 187 feet in Wetland F. The second man-made conveyance is just south of the intersection of British Drive and Windsor Drive and is approximately 790 feet long, 3 feet wide and 2 feet deep. The third man-made conveyance is just southwest of the intersection of British Drive and Buckingham Drive and is approximately 307 feet long, 3 feet wide and 2 feet deep. The fourth man-made conveyance is just southwest of the intersection of British Drive and Dover Drive and is approximately 249 feet long, 3 feet wide and 2 feet deep. With the exception of the northwest boundary man-made conveyance portions that are included in wetlands A, D, and F, the balance of these man-made conveyances appear to have been excavated from uplands and do not exhibit signs of relatively permanent flow. None of these man-made conveyances have been maintained, and only the large conveyance along the northwest boundary was found to regularly contain water and aquatic vegetation. The lesser conveyances are shallow and contain only spotty aquatic vegetation. Accordingly, the man-made conveyances and portions of these conveyances not located in jurisdictional wetlands were determined to be non-jurisdictional, and therefore not regulated under Section 404 of the Clean Water Act..
