Explain: **The project review area includes four wetlands that were determined to be isolated. Wetlands 6, 7 and 8 are surrounded by uplands and sit lower in the landscape than surrounding uplands. No ditches or swales were observed coming out of these wetlands that would provide a surface hydrologic connection from the wetlands to a water of the U.S. Wetland 5 is also surrounded by uplands. The western edge of Wetland 5 is separated from an offsite roadside ditch/swale along Seewee Road by about 10 feet of uplands. There is no evidence of a discrete hydrologic connection**

from the wetland through the uplands to the roadside ditch/swale. No ditches or swales were observed coming out of Wetland 5 that would provide a surface hydrologic connection from the wetland to a water of the U.S. In addition, there are no apparent ecological interconnections from the wetlands 5, 6, 7 and 8 to a water of the US. There also appears to be no subsurface hydrologic connection, and no physical, chemical, or biological connection, to waters of the US. Therefore, Wetlands 5, 6, 7 and 8 were determined to be isolated, non-jurisdictional and not subject to regulation under Section 404 of the CWA.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

As described above, Offsite Wetland 9 is contiguous with and flows directly into Offsite Tidal Creek 1. Based on this information, onsite Wetlands 3, 4 and 9 are considered to be adjacent to the offsite Tidal Creek of the AIWW, which is the TNW. Therefore, Wetlands 3, 4 and 9 are jurisdictional and subject to regulation under Section 404 of the CWA.

The freshwater wetland system flows to the east, then to the south where it flows into the AIWW. The freshwater wetland system includes several ponds. A review of historic topographic maps show that the most downstream end of the existing pond that abuts the AIWW, was constructed after 1943 and indicates that the pond may have been excavated from freshwater wetlands and/or constructed in tidal marsh of the AIWW. The downstream end of this existing pond appears in a 1957 aerial photograph indicating that the pond was constructed between 1943 and 1957. Historic aerial photographs indicate that the upstream ponds were excavated between 1989 and 1994 from areas that appear to be wetlands. The offsite freshwater wetland system, including the series of ponds/excavated wetlands, are separated from the AIWW by a road crossing/berm with a culvert or water control structure. It is unknown if water from the freshwater wetland/pond system flows freely into the AIWW, if it receives tidal flow from the AIWW and/or if the tidal flow from AIWW into the freshwater wetland/pond system is restricted or otherwise managed. Based on this information Onsite Wetland 2 is considered to be adjacent to the AIWW, which is the TNW, and is therefore jurisdictional by definition and subject to regulation under Section 404 of the CWA.
