At some time in the past, a causeway was constructed which separated the wetland, and the area converted to freshwater wetlands. A spillway with a mechanical valve exists and is used to control water flow into and out of the wetland. There is a second (a)(1) freshwater wetland (designated Jurisdictional Wetland B) which is 0.155 acres. The project area includes 0.639 acres of (a)(1) TNW critical area.

*NOTE:* If the navigable water is not subject to the ebb and flow of the tide or included on the District's list of Section 10 navigable waters list, DO NOT USE THIS FORM TO MAKE THE DETERMINATION. 

As a result the site is subject to regulation under Section 404 of the Clean Water Act and/or Section 10 of the Rivers and Harbors Act.
