jurisdictional. The wetlands are 0.61 acres and are surrounded by uplands and are positioned lower in the landscape than the adjacent uplands and had no linear features coming out of the wetlands. Wetland 1 is 0.09 acres and is isolated in the middle of the project area. The surrounding landscape slope into Wetland 1 with no outlet for the water that collects there. Wetland 2 is 0.51 acres and is isolated by a raised access road. The road is used to maintain a utility line and keeps water from flowing out of the wetland area. Wetland 3 is 0.01 acres and is isolated by Richie Way, an unimproved gravel road. There is no evidence of flow from the wetland to another aquatic resource. No evidence of discrete surface hydrologic connections through the uplands to other waters of the U.S. was observed. There was also no apparent shallow subsurface hydrologic connections, and no apparent physical, chemical, or biological connections, to waters of the U.S. In addition, the wetlands have no apparent ecological interconnection to waters of the U.S. For these reasons, the wetlands were determined to be isolated and non-jurisdictional, therefore not regulated by Section 404 of the CWA.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

There is no discernible connection between the wetlands and any other waters of the U.S; therefore the project site is not subject to regulation under Section 404 of the Clean Water Act or Section 10 of the Rivers and Harbors Act.
