collect stormwater runoff onsite. Both ponds were vegetated and would meet the three parameters of a wetland. The pond to the east appears to have been constructed during the initial clearing and grading of the site in 1989. The second pond was added around 2010. The ponds are non-jurisdictional and not subject to Corps regulatory authority under the Clean Water Act.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form documents the jurisdictional status of a wetland directly abutting a pRPW offsite. The property includes one 2.3 acre jurisdictional wetland within the jurisdiction of the Clean Water Act. Two additional non-jurisdictional upland excavated ponds were also located onsite. These upland dug features were constructed for the purposes of gathering stormwater.
