C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: **This form addresses a 1.95 acre forested commercial lot that was determined to be void of aquatic resources. A site visit conducted on 8/30/16 revealed that the site lacked indicators of hydrology and that soils on site did not meet a hydric soil criterial due to the presence of greater than 30% uncoated sand grains throughout. Vegetation on-site consisted of primarily loblolly pine, bracken fern, privet, and wax myrtle. One non-jurisdictional ditch is located on site. This feature was determined to have been excavated out of uplands and to drain only uplands. This feature originates and terminates within uplands on-site. No culverts were observed during the site visit.**
