wetland as outlined in the Corps' 1987 Wetland Delineation Manual. The parameter specifically not present was the hydric soil parameter. Agent's data form revealed the soil had more than 30 percent uncoated sand grains in the upper surface therefore not meeting any hydric soil indicators.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is a 0.227 acre undeveloped residential lot surrounded by developed residential lots, public road and Golf Course Lake. The adjacent properties have been developed within the same NWI classification, and soil type as the project area (PFO1B & Lynn Haven) which both indicate wetlands onsite and within the developed neighborhood. However, the Agent's submitted data forms revealed that the three parameters that are required to define a wetland as outlined in the Corps' 1987 Wetland Delineation Manual (hydric soil, hydrology, and hydrophytic vegetation) are not present within the project area. Specifically, the project area lacked the required parameters of Hydrology and hydric soils and therefore does not meet the definition of a wetland. In addition, a site visit was not warranted based on the submittal by the agent which included site photos and completed data forms which indicated the project area to be all uplands, as well as review of aerial photos which depict developed residential lots adjacent to the project area that are mapped with the same hydric soil type and NWI classification as the project area.
