C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A desktop review was completed on September 21, 2017. All available resources were used to make the determination. The aerial, topographic, soil survey, hillshade, and national wetlands inventory maps were used to complete the determination process. The topographic map does depict a blue line feature in the northwest portion of the site. The hillshade map also depicts the linear feature. However, after review it was determined that the blue lined feature, and all the other ditches located on the property, were non-jurisdictional upland excavated ditches that were constructed for the purpose of draining uplands. The soil survey maps the majority of the site as Coxville and Rains sandy loam soils both of which are hydric. A portion of the northwest corner of the site is mapped as Lynchburg sandy loam soil which is non-hydric. The majority of the site is mapped with hydric soil but the consultants data sheets did not depict that any hydrology was present at the time of the delineation. The national wetlands inventory map depict the entire site as being (U42P) Uplands. After gathering and reviewing all of the necessary information, it was determined that the site in question does not include any wetlands and/ or other waters of the United States and consists entirely of uplands.
