**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Documentation submitted by the consultant and prepared by the Corps based on a site visit conducted on Feb 2009 in association with the previous determination detail stream geomorphic indicators of perennial flow as being channel within bed and banks, having a firm sandy bottom clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel of leaves being continuously washed downstream and water flowing after 48 hours from an rainfall event and flowing within the growing season. In addition, other hydrologic indicators observed within the relevant reach of the stream were an even distribution of substrates in the stream channel, evidence of groundwater discharge (Iron Oxidizing Bacteria) and flowing algae.. **B. ADDITIONAL COMMENTS TO SUPPORT JD: Tributary was determined to be an RPW with perennial flow, where flow was determined to be at least 90% of the year under normal climatic conditions. Tributary is considered man-altered providing drainage for adjacent freshwater wetlands. The flow characteristics of the tributary were evaluated along the entire reach and the majority of its length was determined to have a flow regime of perennial.
