Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A single area located west of the coal ash grinders was observed to contain a combination of phragmties (phragmites) and cat tails (typha spp.) as well as saturation at the time of the site audit. However, the soil was dominated by the presence of coal ash and coal ash and particles resulting from years of exposure to the by-product of the adjacent coal fired generating station. The absence of mineral soil at this location meant the third parameter (hydric soils) was not present onsite. According to the NRCS Field Indicators of Hydric Soils in the United States, version 8.1. hydric soils fall into the following categories; organic soils, mucky mineral soils, and mineral soils. Due to the presence of coal ash and lack of mineral soil in the upper 12" during normal conditions, hydric soils were determined not to exist in the area containing saturation and hydrophtic vegetation.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 153 acre tract known as the Winyah Generating Station main campus. The areas utilized for normal operation and maintenance of the generating facility lacked hydric soils, hydrophitic vegetation, and hydrology and are comprised of dry land / uplands.

A single area located west of the coal ash grinders was observed to contain a combination of phragmties (phragmites) and cat tails (typha spp.) as well as saturation at the time of the site audit. However, the soil was dominated by the presence of coal ash and coal ash and particles resulting from years of exposure to the by-product of a coal fired generating station. The absence of mineral soil at this location meant the third parameter (hydric soils) was not present onsite. According to the NRCS Field Indicators of Hydric Soils in the United States, version 8.1. hydric soils fall into the following categories; organic soils, mucky mineral soils, and mineral soils. Due to the presence of coal ash and lack of mineral soil in the upper 12" during normal conditions, hydric soils were determined not to exist in the area containing saturation and hydrophtic vegetation.

No additional ditches or wetlands are located within the site.
