**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

This 6.69 acre site was assessed, in part, on two previous Approved Jurisdictional Determinations: SAC-2015-01556-4E, dated: January 28, 2016 and SAC-2015-01563-4E, dated: December 10, 2015. Both of these determinations classified the project site in its entirety as “Dryland” uplands. While a site-visit was not performed, a thorough review of all available data, aeriels, photographs, and past determinations was conducted. This office concurs with the original findings and assesses the new project boundary as entirely upland as well based on the following statements:

Aerial imagery, ranging from 1994 to 2014, depicts this site as an actively used agricultural field, which is typically indicative of upland hydrology. Bounding the site to the west, is a continuance of the agricultural field that the site is within, to the south and north are residential and commercial properties, and to the east is Highway 58.

While assessing the site with aerial imagery a ~580 foot roadside ditch feature was found adjacent to the eastern project border and Highway 58. This feature was depicted to be off-site by the provided maps, and the applicants environmental consultants specifically verified this feature to be fully off-site and within the road right-of-way. While not on-site, this feature was assessed for jurisdictional waters/wetlands due to its proximity to the project boundary and the following statements substantiate the findings: this feature is off-site in its entirety and does not appear to contain the characteristics of flow of a tributary. The ditch itself is excavated out of uplands for roadway drainage; storm-water conveyance appears to be the only surface water flow it receives, per the topography and known hydrologic features in the vicinity. Furthermore, well drained mineral sand is visible at the surface of the site leading into the ditch on aerial imagery and Google street view, due to agricultural tillage. This sand is non-hydric in nature (see Dillon Co. Soil survey below), thus likely indicating non-hydric soil in, and adjacent of, the ditch. Lastly, NWIs and USGS topographic maps do not depict this feature in any way, nor do they depict forested land or wetlands adjacent of this feature.

Dillon County soil survey, Pg. 17, depicts two soils on-site: Dothan loamy fine sand (0-2% slopes) and Fuquay sand (0-6% slopes); both of these soils are not listed as hydric on the 2016 South Carolina Hydric Soil list for Dillon County.

Dillon East Quad USGS topographic maps depicts a non-forested upland site with one aquatic feature, a closed-oval shaped oval-shaped feature, which continues off-site. This aquatic feature correlates to a slightly lower elevation region of the agricultural farm field this project is located within; however, given the soil type, lack of surface hydrology, and historic land use (agriculture) there is no evidence to support jurisdictional aquatic resources within this area.

ArcGIS LiDAR Digital Elevation Model (DEM) utilizing both colorized and monochromatic “Hillshade” curves were used to assess the site for elevation contrasts typical of aquatic resources, none of which were found on-site. The site consists of flat uplands on the southern portion of the site which slopes into a slightly depressed region within the central to northwestern portion of the site. This depressional region correlates to the oval-shaped blue feature discussed within the Dillon East Quad USGS topography section; this area appears to be a historic small Carolina Bay, but lacks the hydrology and soil for wetland development. Additionally, offsite to the east and running south, adjacent to the site is a roadside ditch (described above) that is visible on the monochromatic curve.

This site was assessed per the provided property maps and on a single basis form.
