C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The onsite wetland is a portion of a larger wetland system that continues west off site. This wetland is mapped palustrine forested (PFO4Ad) on the NWIs and as Coxville, a hydric soil, on the soil survey. According to the topographic map and aerials, the on site perennial RPW intersects with the northeastern boundary of the onsite wetland. Therefore, this wetland was determined to directly abut the on-site perennial RPW.

Based on a review of the topographic map, aerials, and information submitted by the agent, the blue line depicted as intersecting the center of the property was determined to have perennial flow. This tributary is depicted as a solid blue line on the topo map and as a linear feature on the aerials. Pictures submitted by the agent show that this tributary has an OHWM and bed and banks. Flowing water was present. This unnamed tributary flows east into Maple Swamp, a perennial RPW. Maple Swamp flows southeast into the Little Pee Dee River, a TNW.
