Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Potential wetlands on-site, first identified aslow lying depressions in Horry County LiDAR, were examined during site visits conducted on August 21, 2018 and August 29, 2018 and determined to lack indicators of hydric soils and therefore do not meet the required criteria set forth in the 1987 delineation manual for identification of a wetland. Specifically, soils contained greater than 30% uncoated sand grains.

Additionally, one non-jurisdictional ditch is located on site. This feature was examined during site visits conducted on August 21, 2018 and August 29, 2018. The feature was determined to be man-made based on the observation of spoil piles along its entire length and lack of sinuosity. A bore hole excavated at the beginning of this feature revealed a buried collapsed tile. This feature was determined to be a relic agricultural drainage ditch and non-jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
