indicators of hydrology during a period of above average rainfall and therefore do not meet the required criteria set forth in the 1987 delineation manual for identification of a wetland.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**LiDAR, soil survey information and USGS topographic maps. The USGS topographic maps depict a solid blue line feature which is the symbol for perennial flow, Horry County soil surveys depict Megget Loam which is a 100% hydric soil found in flood plains and drainage ways. Horry County LiDAR depicts low elevations and a defined channel. Based on the previously mentioned evidence, this perennial RPW was determined to have flow at least 90% of the year under normal conditions. The wetland evaluated in this determination is contiguous and abuts the perennial RPW. Flow was observed from a public access points along McDowell Shortcut Road.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses an 11.27 acre tract that was determined to contain 0.19 acre of jurisdictional freshwater wetlands that continue offsite and directly abut a pRPW that flows into the Waccamaw River. Additional areas mapped as wetlands on NWIs were examined during a site visit conducted on 8/27/18 and areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements. Specifically, no indicators of hydrology were observed. .**
