- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Wetland D, totaling 0.73 acre, is located within the site. Wetland D is situated in a depressional pocket within the landscape and is surrounded by uplands. During the field visit an erosional feature was observed across White Road that has the potential of providing a hydrological connection to the roadside ditch which flows to P'on Swamp. However it was determined that the erosional feature was not substantial enough to provide apparent surface hydrological connection in a typical year. In addition, Wetland D has no apparent shallow subsurface hydrologic connection. In conclusion, Wetland D has no apparent physical, chemical, or biological connection to waters of the U.S. Wetland D also has no connection to interstate or foreign commerce. Therefore, Wetland D was determined to be a non-jurisdictional, isolated aquatic resource.**

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**C. SIGNIFICANT NEXUS DETERMINATION**
