Based on a jurisdictional determination NWP2007-428, the US EPA determined on February 25, 2008, that wetlands separated by an artificial barrier, which is a road/berm in this instance, does not sever the areas from functioning as one wetland.**

C. SIGNIFICANT NEXUS DETERMINATION
