This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

project review area. The tributary flows through the corner of the project review area, flows through a culvert under Hwy 17 North and continues flowing downstream until it reaches the upper limits of the Wando River. The tributary was flowing at the time of the site visit and displayed a defined bed and bank and an ordinary high water mark. Additionally, a jurisdictional determination, SAC-2006-03433 issued on December 14, 2018, for a tract immediately upstream and adjacent to the project review area, determined that the tributary was perennial. For these reasons, the tributary was determined to be jurisdictional and subject to regulation under Section 404 of the CWA.

Therefore, the tributary and the wetland share a boundary and have a direct hydrologic connection to one another. For these reasons, the wetland was determined to be jurisdictional and subject to regulation under Section 404 of the CWA. There are two linear features also present onsite located within the wetland but they were excavated from the wetland and are considered part of the wetland. The linear features had water present at the time of the site visit but the water appeared to be stagnant. In addition, spoil piles from the excavation of the linear features were also present within the wetland.**
