C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses 32.17 acres of wetlands in Longs, SC. The wetlands on site are contiguous to Jones Big Swamp, a named pRPW. The blue line is depicted within the project boundary; however, the bed and bank of the RPW are located offsite. Aerial photos and LiDAR show the bed and bank of Jones Big Swamp are located outside of the project boundary. NWIs map the project area as a combination of forested wetland and upland. The project area is comprised of the partially hydric soils, Yauhannah fine sandy loam, Eulonia Loamy fine sand, and Wahee fine sandy loam. The hydric soil Megget is also present site on site. The JD package, including maps and wetland data forms, submitted by the Brigman Company was used in this determination. Corps desktop resources and previous adjacent determinations were also used for this determination.
