**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: sRPW T1 derives its peak seasonal flow regime from a network of roadside ditches, as well as from seasonal groundwater input when water tables are elevated. This tributary is a first order stream reach that contributes mainly roadside runoff which includes metals and petroleum constituents well-known from roadway flushing. sRPW T1 also has the capacity to carry a moderate contribution of primary productivity and minor flow volume downstream to Sawmill Branch, and on to the Ashley River TNW.**

In addition, the regulator who prepared this assessment lived next to Sawmill Branch for 12 years, drove past it twice each day where he was able to directly observe it's perennial flow.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD: There were two tributaries on this site. T1 is a perennial RPW (Sawmill Branch) and T2 is a seasonal RPW which flows to Sawmill Branch. There were no wetlands on the site. A 0.034-acre depression was present on the site and appears to be the remnant of an historic excavation for unknown reasons. The depression did not meet the definition of tributary or wetland and did not carry flow to waters of the U.S.**
