- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **This office has determined that isolated Non-Jurisdictional Wetland A (0.159 Acre), Non-Jurisdictional Wetland B (0.159 Acre), Non-Jurisdictional Wetland C (0.155 Acre), and Non-Jurisdictional Wetland E (0.797 Acre), as documented in Section III Part F of this form, have no physical, chemical, or biological connection to waters of the U.S. (WOUS), including any apparent surface or shallow subsurface hydrologic connection. Wetland A, B, and C are lower in elevation than surrounding uplands and are entirely surrounded by uplands. Additionally, Wetland E is surrounded by uplands to the north, east, and, west, but continues offsite onto the adjacent property to the south and is part of a wetland area on that adjacent property. Even though Wetland E continues offsite, it has been determined that Wetland E is a non-jurisdictional, isolated wetland due to the fact that it too is surrounded by uplands and there is no apparent evidence of ecological interconnectivity between the wetland and WOUS; as well as, no apparent connection to interstate or foreign commerce. On this basis, this office has determined that Wetland A, B, C, and E are isolated from WOUS and are not within the jurisdiction of the Clean Water Act.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
