1) A 0.09 acre shallow broad depression. This 0.09 acre low area was originally assessed to be a wetland by the applicant's environmental consultant, but was found to be entirely upland on an August 9, 2019, site visit by the Corps. On-site, and within the proposed wetland, the Corps noted dry sandy soil lacking hydrological indicators.

2) A ~140 linear foot long 12 inch PVC pipe that begins within the central portion of the site and terminates at the banks of the Black River, this feature was likely installed for storm- water drainage and was not conveying water at the time of the site visit.

3) This site is immediately adjacent to the Black River, however according to the applicant and their environmental consultant no portion of the project boundaries intersect with the HTL/OHWM of the Black River.

While on-site on August 9, 2019, no areas of jurisdictional/non-jurisdictional WOUS were found by the Corps.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
