- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

Within the project site boundary are two non-jurisdictional features:

- 1) A ~500 linear foot section of a ~3,300 linear foot excavated storm water ditch. Within the project site, this feature was excavated out of NWI defined uplands and engineered for the purpose of storm water conveyance. This ditch does not feature natural bed and banks nor an OHWM. Additionally, on recent Google Earth aerial imagery, dated December 11, 2011 – February 2, 2017, the ditch appears to be dry mostly year-round, and features isolated ponding, but not flow, occasionally. This ditch is a manmade feature excavated out of uplands for the sole purpose of storm-water conveyance and, therefore, was determined to be a non-jurisdictional feature.
- 2) One (1) 0.77 acre isolated wetland, contained within an elevation depression that does not have outflows. All water contained within the wetland is retained within the wetland boundary and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetland was determined to be isolated, non-jurisdictional and not connected to any other waters of the U.S. The onsite isolated wetland was also determined to have NO substantial nexus to interstate (or foreign) commerce. This feature can be seen on LiDAR digital elevation model aerial imagery as a slight depression with no significant means for conveyance leaving the depression; one minor linear depression can be seen leading out of this feature, but during the onsite investigation, only superficial changes in elevation were noted with no evidence of flow. This linear depression appeared to be a depression between planted pine (silviculture) bedding rows. On an August 21, 2019, site visit the wetland was assessed and found to be broad shallow depression with wetland indicators within it, including watermarks on trees, hydric soils, and local geography that matches the LiDAR depiction; the findings on-site matched the delineation map submitted to the Corps. Approximately four feet outside of the delineated wetland boundary, at a ~1 foot rise in elevation, dry loamy soil lacking hydrological indicators was found.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

## B. ADDITIONAL COMMENTS TO SUPPORT JD:

This 17.00 acre site is described as a pine plantation bounded by Interstate 95 to the west, Pine Needles Road to the north, and adjacent land owners to the south and east.

A site visit was conducted on August 21, 2019. During the visit, it was determined that the area exists as it was depicted in the report and associated map titled: “Wetland Delineation/Determination / **Pinnacle Storage** / Florence County, South Carolina / Tax Map Number 00075-01-219 (Portion of)”, dated July 3, 2019;

Within the project site boundary are two non-jurisdictional features: 1) A ~500 linear foot section of a ~3,300 linear foot excavated storm water ditch. Within the project site, this feature was excavated out of NWI defined uplands and engineered for the purpose of storm water conveyance. This ditch does not feature natural bed and banks nor an OHWM. Additionally, on recent Google Earth aerial imagery, dated December 11, 2011 – February 2, 2017, the ditch appears to be dry mostly year-round, and features isolated ponding, but not flow, occasionally. This ditch is a manmade feature excavated out of uplands for the sole purpose of storm-water conveyance and, therefore, was determined to be a non-jurisdictional feature. 2) One (1) 0.77 acre isolated wetland, contained within an elevation depression that does not have outflows. All water contained within the wetland is retained within the wetland boundary and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetland was determined to be isolated, non-jurisdictional and not connected to any other waters of the U.S. The onsite isolated wetland was also determined to have NO substantial nexus to interstate (or foreign) commerce. This feature can be seen on LiDAR digital elevation model aerial imagery as a slight depression with no significant means for conveyance leaving the depression; one minor linear depression can be seen leading out of this feature, but during the onsite investigation, only superficial changes in elevation were noted with no evidence of flow. This linear depression appeared to be a depression between planted pine (silviculture) bedding rows. On an August 21, 2019, site visit the wetland was assessed and found to be broad shallow depression with wetland indicators within it, including watermarks on trees, hydric soils, and local geography that matches the LiDAR depiction; the findings on-site matched the delineation map submitted to the Corps. Approximately four feet outside of the delineated wetland boundary, at a ~1 foot rise in elevation, dry loamy soil lacking hydrological indicators was found.

This feature matches the approximate location and extent of the storm-water ditch discussed in section II B. 2. On topographic maps, the ditch feature continues off-site through an adjacent parcel, crosses under train tracks by means of a culvert, continues through an agriculture field, and then terminates in the upper reaches of the Middle Swamp drainage basin. The path of this ditch also is readily identifiable on recent aerial imagery and LiDAR; NRCS Florence County soil survey, sheet 9, depicts the soils on-site to predominately be Coxville fine sandy loam. Additionally, in the southwestern portion of the site are minor intrusions of Duplin fine sandy loam and Norfolk loamy sand. Coxville and Duplin fine sandy loams are both listed as hydric on the 2017 South Carolina hydric soils list for Florence County; National Wetland Inventory maps depict the site as a mix two upland land types, transportation / utility (U14) and upland planted pine (U42P); Florence 1999 Aerial Index 11227:69; SC DNR 2006; Google Earth 2011 – 2017; LiDAR depicts a relatively flat site with one broad diffuse elevation depression within the central portion of the site;

This site was assessed on a single basis form per the provided maps and site information.

Within the project site are zero (0) acres / linear feet of jurisdictional resources and 0.77 acres of federally defined non-jurisdictional freshwater wetlands. The on-site isolated wetland was coordinated with the EPA and USACE Isolated Waters; coordination was considered complete on September 13, 2019, with no questions or comments provided by the agencies.
