- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Within the project site is a ~155 linear foot section of a ~3,200 linear foot excavated drainage ditch. This feature is excavated out of NWI defined uplands, does not connect multiple known jurisdictional waters, and was engineered for the purpose of storm water conveyance. On recent Google Earth aerial imagery, dated September 2005 – March 2019, this linear feature is oriented east – west, bounded by vegetation, and excavated out of agriculture fields. On Google Street-view dated February 2008, no discernable tributary or ditch can be seen within the project area; the ditching may be either very minor and masked by vegetative growth, or buried and contained within culverts within the extent of the project site.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Norfolk loamy sand is listed as hydric on the 2017 NRCS South Carolina hydric soil list for Darlington County.; National Wetland Inventory depicts the site in its entirety as upland cropland / pasture (U21).; Darlington 1999 Aerial Index 11225:221; SC DNR 2006 Aerials; Google Earth 2005-2019; Google Street-view 2008; LiDAR digital elevation model aerials depict a flat site with one linear feature, the excavated ditch discussed in section II B.2, cutting perpendicularly through the central portion of the site. No other features of note are seen within the project area.

Within the project site is a ~155 linear foot section of a ~3,200 linear foot excavated drainage ditch. This feature is excavated out of NWI defined uplands, does not connect multiple known jurisdictional waters, and was engineered for the purpose of storm water conveyance. On recent Google Earth aerial imagery, dated September 2005 – March 2019, this linear feature is oriented east – west, bounded by vegetation, and excavated out of agriculture fields. On Google Street-view dated February 2008, no discernable tributary or ditch can be seen within the project area; the ditching may be either very minor and masked by vegetative growth, or buried and contained within culverts within the extent of the project site.

This site was assessed on a single-basis form per the provided maps and site information.
