According to Lidar imagery the on-site ditch is part of a closed boundary linear feature that continues off-site to the north wholly within uplands.
Non-Jurisdictional Feature B	0.33 acres	(b)(9) Water-filled depression constructed/excavated in upland/non-jurisdictional water incidental to mining/construction or pit excavated in upland/non-jurisdictional water to obtain fill/sand/gravel	Non-Jurisdictional Feature B is a water-filled depression that does not meet the 3 parameters of a wetland and was excavated entirely in uplands. Non-Jurisdictional Feature B has no connection/outfall to any downstream water.
Non-Jurisdictional Wetland A	1.29 acres	(b)(1) Non-adjacent wetland	This wetland is a closed boundary polygon that is not contiguous to or directly abutting an (a)(1)-(a)(3) water. In addition, this wetland does not meet any of the other (a)(4) criteria for adjacency and thus is an excluded water pursuant to (b)(1).
Non-Jurisdictional Wetland B	8.8 acres	(b)(1) Non-adjacent wetland	The on-site wetland continues off-site to the southwest and is part of a larger wetland system. However, according to Lidar imagery the off-site wetland is a closed boundary polygon that is not directly abutting an (a)(1)-(a)(3) water. In addition, the wetland does not meet any of the other (a)(4) criteria for adjacency and thus is an excluded water pursuant to (b)(1).
