However, according to LiDAR data the wetlands both display closed polygon boundaries. Therefore, both Wetlands A and B are not abutting an (a)(1)-(a)(3) water, and further do not meet any of the (a)(4) criteria for adjacency and are therefore excluded waters pursuant to (b)(1).
