C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 2.33 acre site contains no wetlands and one jurisdictional tributary. Although a portion of the site is mapped hydric soils and palustrine wetlands, a data form taken by the agent determined that the site does contain hydric soils and hydrophytic vegetation; however, no indicators of hydrology are present. The jurisdictional tributary on site was determined to have perennial flow based on a review of the aerials, topographic map, soil survey, and NWIs. This perennial tributary flows south into the Pocotaligo River, which flows southeast into the Black River, a Section 10 waterbody. The remainder of the site is comprised of uplands.
