- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **There is one upland excavated non-jurisdictional ditch located on site, that was determined not to be a tributary. This feature was determined to have been constructed in uplands and to drain only uplands. Based on site photos submitted by the agent the ditch does not have flowing water, the channel of the ditch is filled with leaf litter and debris, and the ditch does not appear to have a continuous OHWM. Additionally, potential wetlands (depicted on NWIs) onsite do not meet the required criteria for identification of a wetland, specifically, based on data sheets submitted by the Brigman Company, potential wetlands onsite lack indicators of hydrology under normal conditions and hydric soils were not observed.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

There is one upland excavated non-jurisdictional ditch located on site, that is determined not to be a tributary. This feature does not have OHWM or sinuosity, was excavated out of uplands and drains only uplands. Due to the consistency in the depiction of uplands throughout USGS topographic information, data sheets submitted by the Brigman Company, site photos, and aerial photographs, the project area was determined to be void of any aquatic resources.
