Explain: **On the east side of the subject property is a 1.23-acre isolated wetland as depicted on the plat labeled "Plat of 155 Droze Rd, TMS: 136-00-00-093 surveyed for Paul D Grove". Confirming with Lidar, the National Wetland Map**

Inventory, the Corps RegViewer Hillshade layer, and a previous AJD dated February 14, 2017, this wetland is determined to be an isolated wetland.

Additionally, a topo survey and drainage study were performed by Forsberg Engineering & Surveying (dated June 14, 2022). The study determined there is an existing ditch along the north side of Droze Road that intercepted drainage from the parcels and lanes on the north side of the road and channeled that runoff to the east to Parsons Road. However, at station 28+50, a 15" RCP pipe was installed to re-direct that north-side drainage into the south side of Droze Road and into the property that is the subject of this wetland delineation/jurisdictional determination. The drainage swales along the shoulders of both sides of Droze Road were re-graded to drain into the 15" RCP pipe, which creates a point-source discharge into the subject property without any apparent connection to a downstream ditch, channel, or waterbody. The wetland continues offsite to the east; however, per Lidar, the wetland in its entirety is surrounded by uplands that slope toward the wetland with no outlet for the water that collects in this land feature. Also, there is a remnant agricultural ditch running straight south from the wetland, but it terminates at the property boundary where there is an impervious parking lot on the adjacent parcel to the south.

There are no apparent shallow subsurface hydrologic connections, and no apparent physical, chemical, or biological connections, to waters of the U.S. This wetland has no ecological interconnection to waters of the U.S., nor does it have an apparent connection to interstate or foreign commerce, for these reasons the wetland was determined to be isolated and not regulated by CWA jurisdiction.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

project boundary that is not subject to the CWA; specifically, the feature is an isolated, depressionnal, forested wetland. The majority of the property is undeveloped with one residence in the northwest corner. Neighboring properties contain a mix of undeveloped parcels to the north, east, and west, and commercial development to the south. The feature is a depressionnal wetland area that is not connected to any navigable water(s) and is not tributary to navigable water(s); nor is there any connection to interstate or foreign commerce. The wetland exhibits no apparent flow/conveyance to waters of the United States; no physical, chemical, biological connections; and no apparent shallow subsurface flow connections to other waters. Furthermore, the wetland does not appear to exhibit any apparent ecological interconnectivity with other water features, including any waters of the United States. Based on this information, this office has determined that the specified wetland feature documented on this form is considered isolated and not subject to jurisdiction under the CWA.
